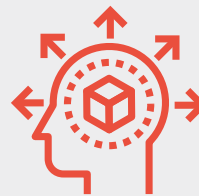

According to Infrastructure Australia's report Infrastructure workforce and skills supply (published October 2021), demand for labour is going to reach "unprecedented levels" by 2025.

The report warns that labour shortages may peak "at a likely shortfall of 93,000 workers in early 2023 or 48% higher than projected supply".

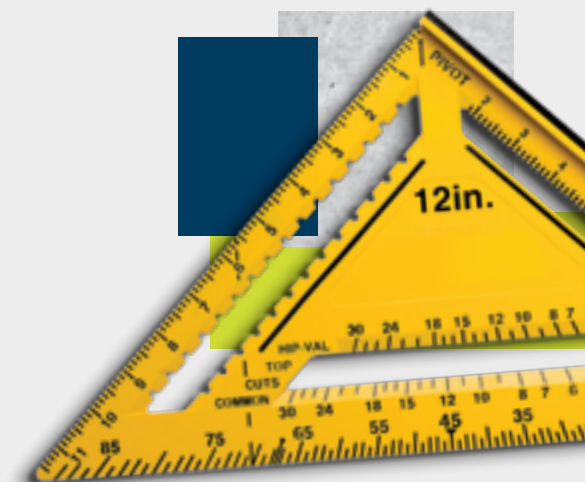

- Learners are required to be competent in written and spoken English and will undertake a Language, Literacy and Numeracy test prior to commencing the training.
- Students will need to possess a minimum AQF 5 level qualification or significant and relevant work experience.

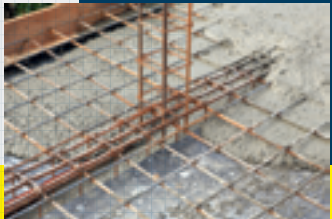

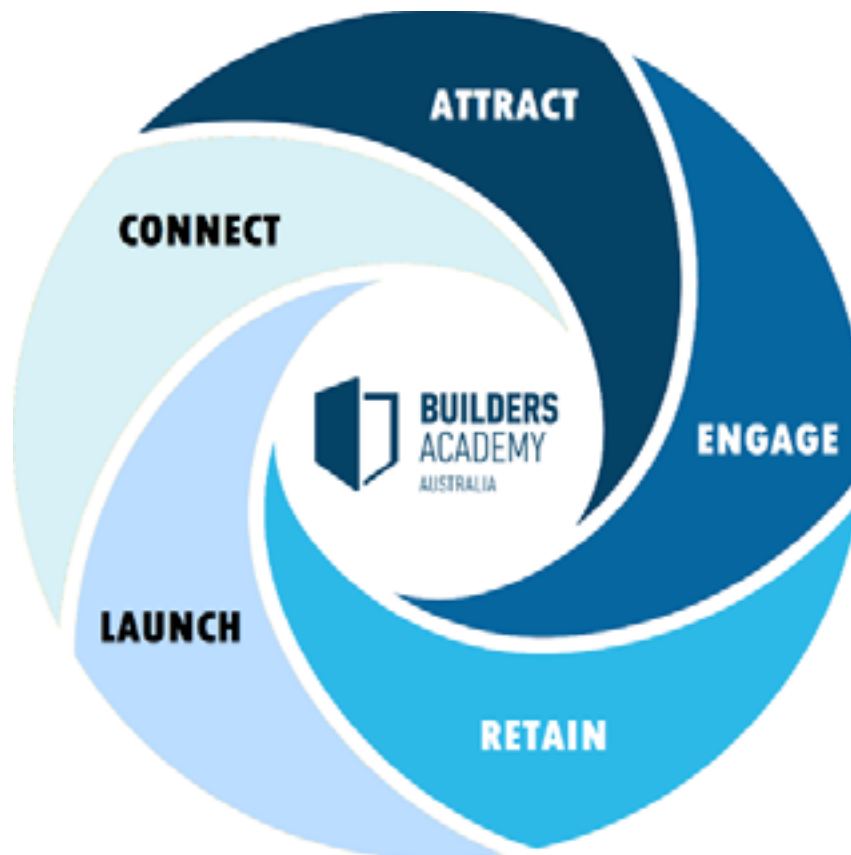

Tuition Protection Service

The TPS may also assist you if you have withdrawn from, or not started, your course and are eligible for a refund of tuition fees and the institution has not paid them.

The TPS will ensure that you are able to either:

- Complete your studies in another course or with another institution, or
- Receive a refund of your unspent tuition fees.

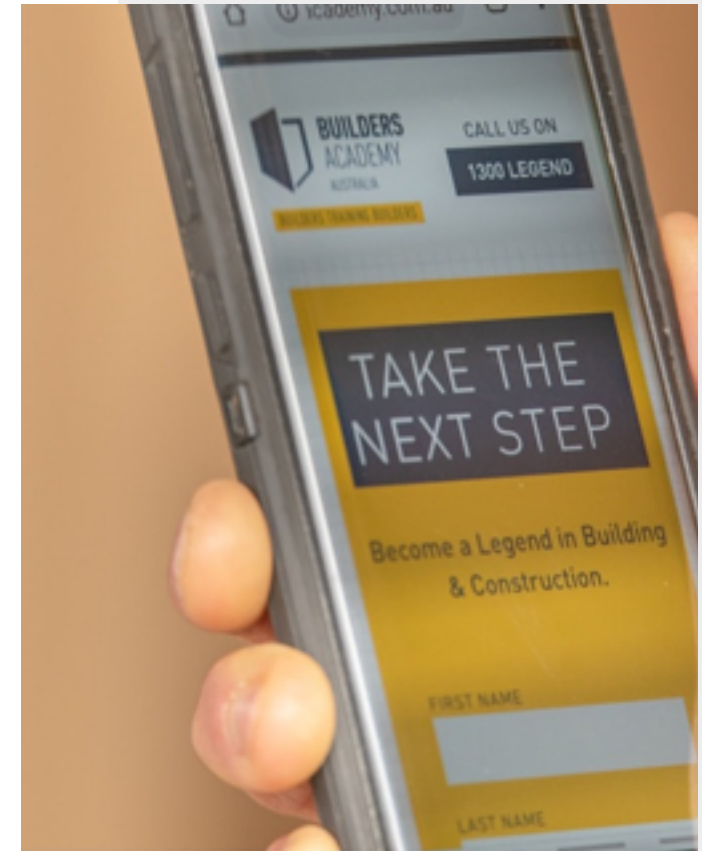

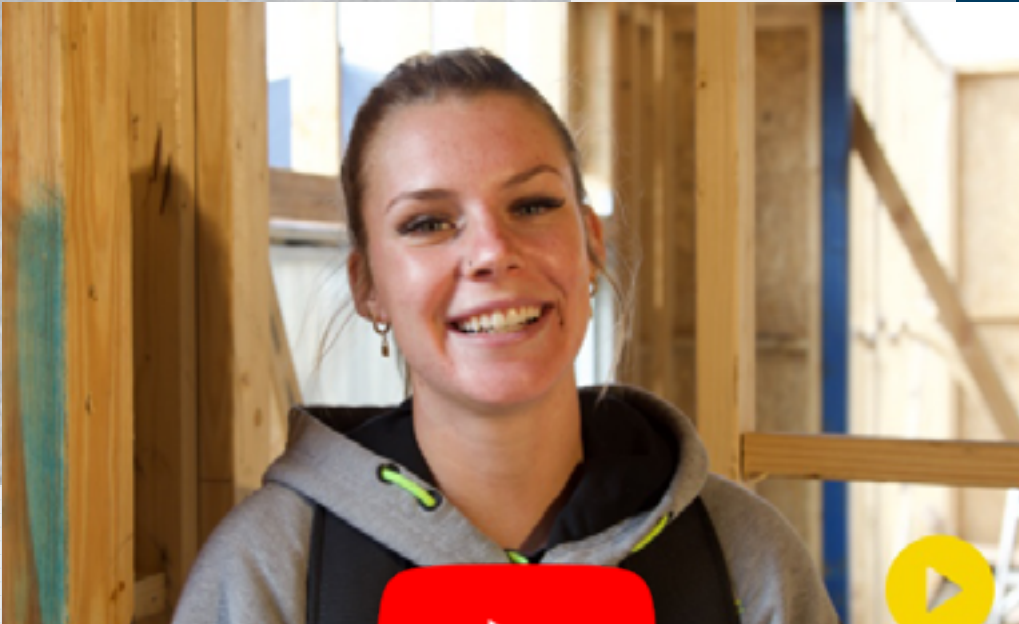

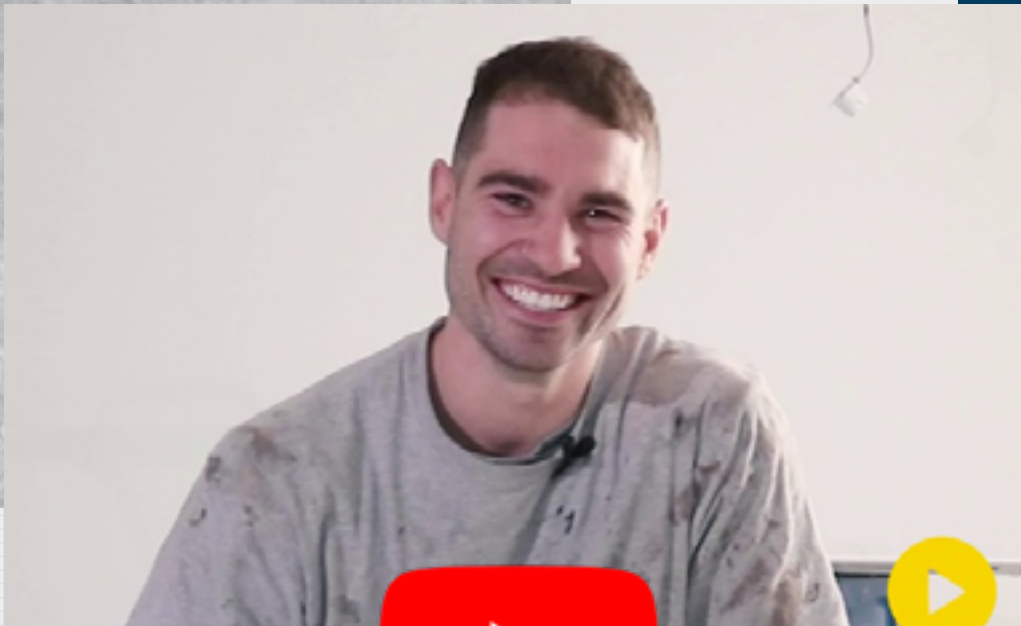

APPLICATION PROCESS

HOW TO APPLY



STEP 1: APPLICATION FOR ENROLMENT

International students should apply via an authorised Builders Academy Australia (BAA) agent/representative or directly online via our <https://enroller.app/baa/enrolment-application>; attaching all required documents (e.g., academic transcripts).

STEP 2: LETTER OF OFFER

BAA will advise you of the outcome of your application within two days. Some applications (e.g., those requiring external verification) may take longer to process, as additional information is required. Credit transfer applications usually take extra time.

If your application to BAA is successful, BAA will send a Letter of Offer to you or your agent, confirming the course you have been offered, fees payable and course commencement date. To accept the offer, you must sign and return the Acceptance Letter and pay the New Student Fee of \$250 AUD. This must be done in 21 days after the date of the Letter of Offer from BAA.

STEP 3: CONFIRMATION OF ENROLMENT

Upon receipt of the New Student Fee, BAA will formally notify you that you have been accepted. The electronic Confirmation of Enrolment (CoE) form will be sent directly to your representative if they are assisting with your application. You will need the CoE to apply for your Student Visa.

STEP 4: PAYMENT OF FEES

The invoice in step 2 will advise you of the amount and due date for payment. If you receive the Letter of Offer within 60 days or less of the commencement date, then full fees are payable immediately upon receipt of this letter.

STEP 5: STUDENT VISA APPLICATION

International students intending to study at BAA must apply for a Student Visa. [For more information regarding student visas click here.](#)

STEP 6: NEW STUDENT INFORMATION PACK

Approximately six weeks prior to course commencement, you will be sent an information pack outlining what you need to bring and answers to frequently asked questions. New students should also advise BAA when they will arrive at campus and if pickup is required. Please ensure that the BAA Admissions Office has your correct personal email address.
